PURPOSE OF POSITION:

To ensure a safe, pleasant and efficient pick-up and delivery process while assisting CROSS clients, volunteers, vendors, and donors to collect and distribute donations.

PRIMARY ACCOUNTABILITIES:

Garage

- Organize garage area (Ensure all items located in the garage are placed in their designated location after each shift)
- Ensure the outer area by the garage doors remains clear of debris with safe exit and entrance ability

Management of Donations

- Retrieves donations in a timely, friendly, and efficient manner
- Records donations appropriately and makes receipts for donors when requested
- Loads, picks up and unloads regular food rescue donations, product drives, and special donations as needed
- Move clothing, school supplies, holiday merchandise into designated areas of the warehouse
- Delivers 100% of the donated product to CROSS in a timely manner to ensure quality and safety of products
- Inspect vehicle equipment and supplies. Report vehicle maintenance needs, and perform light maintenance such as maintaining air pressure in tires, maintaining vehicle fluids, and installing bulbs.
- Maintain cleanliness of vehicle.

Other

- Works with the Warehouse Manager to recruit, train, and supervise delivery volunteers and interns
- Supports CROSS at events and community booths as needed
- Other duties as assigned
